Location

The restaurants are situated within three railway arches in close proximity to Southwark Underground station (Jubilee Line). Scoresby Street (via Dolben Street) is the cut through between the underground station and Southwark Street. Southwark is already an established office, restaurant and leisure destination.

Scoresby Street is currently home to a number of bars and restaurants including: Nando's, Flying Fish Sushi, Mar I Terra and Blackfriars Wine Bar. These restaurants are in close proximity to the recently redeveloped Union Yard Scheme where occupiers include: Union Street Theatre, Macellaio RC, Balabaya, Spanish Theatre and Flying Fantastic. Other nearby restaurants include: The Baltic Restaurant, The Anchor & Hope PH and Gordon Ramsey's Union Street Cafe.

Description

The accommodation has recently been updated with new glazed arch frontages with bi-folding doors. The arches have strip lighting and capped services including gas, electricity, water and waste. It may be possible to place tables and chairs on the pavement outside, subject to local authority consent.

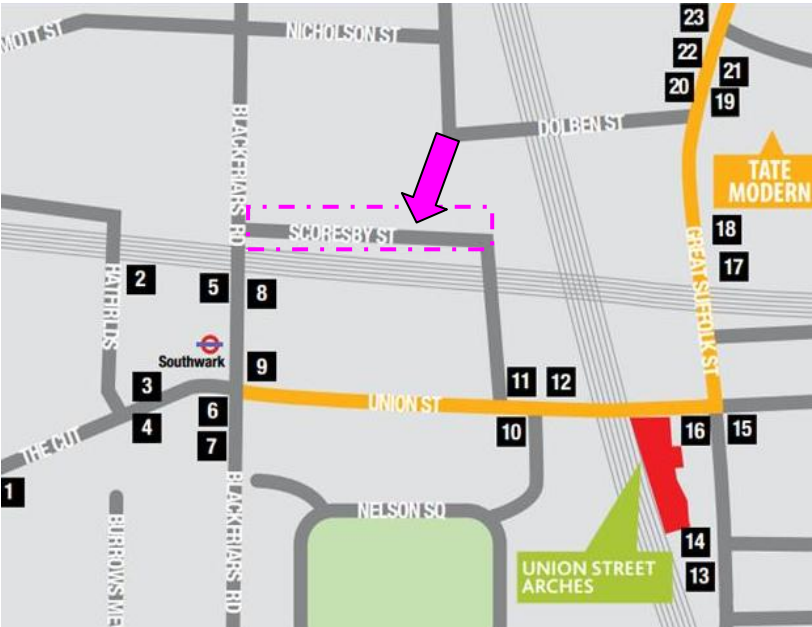
