The site lies close to the corner of Station Approach and Worsley Bridge Road, which is approximately 5 miles South East of Central London. Description

A single storey factory unit of steel truss constructions with brick elevations having been broken up in to smaller units. The internal height to the truss is approximately 3.65m. The front two storey section (former offices) are brick built with a flat roof. There is a small forecourt area providing loading and parking facilities. The units would suit a variety of occupiers within B1(C), B2 and B8.




